

Triple P Training Consultants

Triple P America (TPA) is seeking genuine expressions of interest from professionals and bilingual professionals with expertise in clinical or educational psychology (or qualifications and experience in a similar field) to become part of the team of Triple P Training Consultants.

A number of contract positions are available within the East Coast and Central time zone region, with some of these being bilingual positions (Spanish/ English).

TPA is the organization responsible for the dissemination of the Triple P-Positive Parenting Program[®] (Triple P) in the US. Triple P is an evidence-based multi-level family intervention program for the prevention and treatment of behavior problems in children and adolescents. This award winning program promotes the independence and health of families by enhancing parents' knowledge, skills and confidence and is based on decades of research and clinical trials. Triple P Training Consultant Duties:

Consultants are contracted to TPA to train and accredit practitioners from a variety of disciplines (i.e. health, education and social services) in the delivery of Triple P interventions for parents of children and adolescents. This includes:

- Delivery of one to five day active skills training programs with a follow-up accreditation process to assess participants' parent consultation skills.
- Technical assistance and consultative support to organizations adopting Triple P.
- Assisting with large group parenting seminars and engagement strategies with families and organizations.

These assignments would be determined by TPA and negotiated depending upon trainer's availability and work flexibility however consultants must have at least 10 weeks per year of availability to undertake training

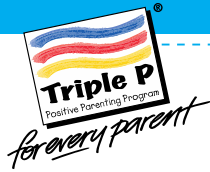
Qualifications and experience required for the Triple P Training Consultant role include:

Post-graduate degree in psychology (e.g., Masters, PhD), preferably clinical or educational (or related field)

- Clinical experience working with children and families
- Experience in group facilitation and/or teaching

Knowledge and understanding of the following areas:

- *Clinical and educational psychology*
- *Family intervention*
- *Cognitive behavioral therapy*
- *Child and adolescent development*



- Child and adolescent assessment and intervention
- Child and adolescent psychopathology
- Effective teaching
- Promotion and marketing

Familiarity and experience with Triple P, particularly being an Accredited Triple P Provider, is preferable although not essential.

Essential attributes of Triple P Training Consultants include:

- An ability to engage in active problem solving
- Resiliency and stress tolerance
- Respect for participants in training courses and their diverse characteristics whether they be in relation to personality, race, religion, nationality, or cultural background
- An ability to work with others and to facilitate groups working effectively together by employing a variety of strategies and skills
- Excellent communications skills, including the ability to communicate, in a discrete way, authority, confidence and leadership in a teaching/training situation as well as the ability to connect with the audience.
- The ability to give constructive feedback to course participants in a helpful, positive, non-judgmental way as well as the ability to accept feedback from supervisors
- Integral to the success of a Triple P Training Consultant is a willingness and ability to travel when required within the United States (which may require an extended stay, weekend or out of hours work). Triple P Training Consultants may also have the opportunity to facilitate Triple P Training Provider Courses internationally (e.g., Canada, United Kingdom, Europe).

Employment options and remuneration:

The working relationship between the Triple P Training Consultants and TPA will be outlined for each individual training consultant in a contract. The contract would initially be for a period of 24 months. Attractive terms are offered including travel and accommodation allowance, travel insurance, and a daily meal allowance where applicable.

Successful applicants will be provided with specialist training facilitated by Professor Matt Sanders and are required to attend a 6 day intensive 'Triple P Train the Trainer' course held early March 2015 in South Carolina. Please note this training is available only in English and while travel and expenses will be covered, successful applicants will not be paid for attending the training.
